After months of development, CBD of Maple Lake has released a revolutionary new marijuana infused bait just in time for the ice fishing season owner Mary Jane announced at 4:20 this afternoon.

Concocted in the local store's own basement laboratory, the bait combines the smells fish love with a tincture of THC that will be as addicting to fish as the store's fudge brownies are to humans.

The key to the bait's success is in the two-step process, Jane explained. First a THC oil laced with fragrance is used as a liquid attractant.

"Two or three drops in the water is all it takes," she said. "The fish will home in on the vapor trail and ingest the oil as they swim. Once ingested, they will start to experience a false sense of well-being, then the munchies will hit, that's when you drop the lure."

"My Reefer Oil combined with the Funny Fish Lure is foolproof. Any creature swimming within 50 yards is going to go bananas for it," she said. "If there are fish in the area, you will catch them."

Local bait store owners predict Jane's Reefer Oil and Funny Fish Lures will sell like space cakes and they are eager to get in on the action.

It's already been nominated for best new product of the year and even attracted national attention when a post went viral of the President himself swaying on his yacht to Black Sabbath's "Sweet Leaf" with a lunker on his line.

"This hooch is downright addicting, man," commented 2023 US Bassin Champion Holden Dink, "not to say I've indulged in Reefer Oil myself, although I may have taken a rip from my own stash before this interview, what I mean to say is those fish won't stand a chance once they puff the dragon."

Despite local bait shop's eagerness to carry the product in their stores, Jane says she plans to sell it exclusively at Maple



# City councilors are appalled by city flag finalists FLAG 1

The Maple Lake City Council held a special meeting Thursday to review submissions for a new city flag, a process that called into question what is art, and do we really want it waving boldly high above City Hall?

Councilors voted last month in favor of designing a flag that would be a visual symbol representing Maple Lake's great people, storied past, and natural beauty. Rigid stipulations were set (which no one paid attention to) and an invitation drafted to all local artists for the chance to have their work on display above all others

(literally as it would be strung to the top of a very tall pole).

Stipulations included: Nothing too flamboyant, or too dull; nothing too abstract but realism should be avoided; refrain from using geometrical shapes and squiggly lines (we are not in kindergarten folks) and lastly, representations of citizens, living or deceased are strictly prohibited.

Councilors were disappointed to receive only four submissions and were further disappointed at the quality of the submissions, or lack thereof.

Councilor Ileane Wright opinioned that the no squiggly line stipulation was like tying artists' hands behind their backs and asking them to paint with their teeth. "It's just another example of big government sticking their fingers where they don't belong," she said. "We should let art be art."

Her comment led to hours of bickering about what delineates good art from bad art, which this journalist will edit from her report and spare you the agony of reading except for this one thought, is not the best art, that which is left open to interpretation? Either way what the council had before them could not be considered in any way to be art.

In fact, the submissions were so terrible,

councilors who had earlier decided to simplify democracy by choosing the new flag themselves at a closed meeting, in an uncharacteristic put the designs to a vote

Maple Lake city council member, lleane Wright, had high hopes for a new city flag design. Wright believes the ridiculous stipulations tied the hands of artists, and by the looks of the entries Maple Flake editors literally, couldn't agree more!

best of some of the worst specimens they'll likely ever see. Just to prepare you for the horrors, you will find a detailed description of each design submitted by the artist in the sidebar at right.

Counselors ask that the public vote very conscientiously despite the abysmal options and consider the following before making a decision:

- 1. Will this design stand the test of time? "We don't want anything that's going to go out of style like skorts or jelly sandals," Councilor Helen Bach said. "There's no way I'm going through this torture again just to make our flag more relevant to the times."
- 2. Will this design make Maple Lake stand out above the rest? "I don't think this will be a problem, any one of these designs is going to draw attention, in fact, I bet we'll be laughed at for many years to come," Councilor Jerry Atrick said.
- 3. Does it use meaningful symbolism? For legal reasons City Attorney Sue Yoo advises voters to abstain from selecting a design with shapes or pictures that could be in any way considered obscene, offensive, or mistaken for body parts.



### FISH OR FIB?

# Derby takes steps to freeze future fiascos

technicality has been fixed after Ben Makinitup won an arbitration settlement for the heaviest fish at the 2022 Maple Lake Ice Fishing Derby, officials reported.


Makinitup drove off with the top prize two years ago for a pike encapsulated in a block of snow and ice. As he told the judge at the settlement hearing, there was no rule in the books that stated a fish couldn't be frozen at weigh-in time. His catch also set the record for longest, widest, coldest, and most blocklike.

Makinitup contends the fish was alive and ice free when he pulled it out of the hole and only accumulated its frosty exterior during transport to the weigh-in table. He said the derby committee was at fault for holding its annual contest on such a cold day.

Iban Robbed, the derby volunteer that confronted Makinitup that day, said he knew something was fishy about the man the minute he saw him.

"Here he comes pushing this giant block of ice and he says he wants to submit his catch," Robbed told the Maple Flake. "He claimed there was a fish inside there. I thought he was crazy, but he made me walk around to the other side and after scraping away some of the snow, I could just make out something that may have been a





fish. It was long and greenish so it could have been a pike, or maybe an eel. Does Maple Lake have eels? Anyway, I told him politely to get lost and he says, 'there's no rule my fish can't be frozen.' I laughed because I thought he was joking and without another word he walks over to the wall where we hang the nicest of the catches, grabs one of the fish and slams it down against the weighin table. Broke the table right in half and he says, 'you can't tell me these fish aren't frozen.' I told him the difference was you could tell those were fish. He could have told me he had a woolly mammoth in that block of ice, and I wouldn't have known any better. So, then he storms off and I thought that was the end of it. A couple days later I get a call from the derby president Burt N'urney saying he got a summons from the county courthouse on account of a guy named Ben Makinitup who filed a suit against the derby committee. Can you believe that? Some people will go to any lengths to get their hands on one of those lavish fish houses."

According to the report, Makinitup claimed he would have won for the heaviest fish and was entitled to an Ice Castle Fishhouse or \$50,000. In addition, he wanted a public apology from Robbed at the following year's derby and the official title of Grand Champion 2022.

"I'm surprised he didn't ask for a parade," Robbed fumed.

Robbed told The Flake that the Derby Committee's lawyer, Ima Dufas was so confident Makinitup didn't have a fin to swim with she encouraged them to go to court and when they won, sue Makinitup for damages. To everyone's surprise Judge Norma Lee Lucid ruled in favor of the plaintiff.

One bright spot of the entire ugly affair is Makinitup was required to buy the Derby a new table to replace the one he broke.


The committee has since learned its lesson, said president N'urney. New language has been added to the rule book that states derby judges must determine, without a doubt

the fish being submitted is in fact a fish. Details on the criteria for what constitutes a fish are still being discussed, N'urney said. Some of the suggestions include licking the fish under the assumption if it tastes like a fish and looks like a fish it must be a fish. Another suggestion that was less popular than the licking test, was the smell test in which the fish must be placed in a warm vehicle until it starts to stink. The answer would be in the smell. A game of rock, paper, scissors would determine whose car is used.

"We haven't ironed out all the details yet, but when we're done, it will be fool proof," President Burt N'urney said. Emphasis on the "fool."

"It's like there's a whole other little society living just under the surface of our own," he said.


Now exhausted authorities and frazzled employers are trying to think of a way get residents away from their screens and back to reality.

he Minnesota Legislature is considering a new law that doesn't bode well for lakeshore owners.

The bill introduced by Senator Iova Alltax will charge a yearly property tax for all docks on Minnesota lakes. The law will take effect July 1, 2024, for taxes payable in

The bill, which has bipartisan support, would assess a tax of \$12.50 per square foot lakeshore owner's property.

#### Barn-storming the state

Alltax and a contingent of aides have been barn-storming the state, urging citizens to contact their representatives to vote for the new dock tax.

Recently Alltax stopped in Maple Lake to get feedback from local citizens. Unfortunately, only two Maple Lake residents

"The residential docks of lakeshore property owners are taking up water space and should be taxed," Alltax told the group.

"I already am paying too much in property taxes," said local restaurant owner Sal Minella. "You liberals are always after my hard-earned money."

"I have to laugh when I hear a \$1 million

In 2016, the Minnesota Department of Revenue counted 135,000 non-commercial seasonal recre-

If 75,000 out of 135,000 were taxed an additional \$3,862.50, it would put \$290 million into the Minnesota coffers.

lakeshore owner complain about paying any taxes," Alltax said. "You should count your blessings."

The Minnesota Legislature is considering a new bill that will charge a yearly property tax for all docks on Minnesota lakes, including Maple Lake.

#### **Drones**

The bill includes \$5 million to purchase drones used to identify and measure the docks, boatlifts and floating rafts currently on all Minnesota lakes.

"There will also be costs to hire the drone operators," Alltax said.

The additional charges will be automatically put on the property owner's 2024 tax statement.

"Sadly, we just can't trust individuals to be honest in reporting their docks in the water," Alltax said.

#### Follow the money

"I want to support my state," said Sandy Beach. I am sure the money would be used very wisely. What will the revenue be used for?"

"You don't even live on a lake Ms. Beach, much less have a dock," Sal Minella said. "I bet you would feel differently if the government wanted \$3,862 a year for every one of your darn cats. So, you and your socialist friends should just keep your mouths shut."

Sen Alltax pointed out that the revenues raised by the new tax would go to many different projects to make Minnesota great

"Included will be money for the Department of Natural Resources and earmarks for rural communities like Maple Lake," Alltax said. "Not included will be any tax cuts for the millionaires in our state."

Lake CBD at least until all the kinks are worked out. One of the hiccups she's had to deal with, she said, is finding a way to make the bait less attractive to people. # Ruckus on the Roundabout

Twenty Maple Lake residents are recovering at a local bar after being trapped for more than two hours on the Division Street Roundabout in a shuttle bus bound for Mystic Lake Casino earlier today.

According to witnesses, the bus was heading east on Division Street when it entered the roundabout. The driver reportedly became confused at the multiple exits and was stricken with a sudden inability to commit.

"He kept saying 'on your right is H&H, on your right is H&H' over and over again like a tour guide on a broken record as we went around and around!" said Ron A. Muck, a passenger on the ill-fated shuttle.

For two hours, the blue bus filled with anxious would-be gamblers remained on its circular course until, left with no other option, the National Guard was called in.

"It was so scary," said Ima B. Leever a woman who happened to be walking her dog in the area at the time. "All I remember were those pale, desperate faces pressed up against the glass as they went by me time and time again. I felt so helpless."

By the time the National Guard arrived local law enforcement had already barricaded all five entrances to the traffic circle, and it was starting to disrupt traffic throughout the city. Eventually a portion of Highway 55 was closed as well to serve as a landing pad for the National Guard helicopter. For another half an hour, rescuers debated the best way to stop the bus which continued to race along at

a discouraging 15 mph. After dismissing an idea to tow the bus out of the roundabout with the helicopter – which would have required guardsmen to repel down onto its roof to attach the tow-cables – well known Psychiatrist Mel Practiss was brought in. Using poster-board signs he was able to effectively communicate with the driver, and in as little as five laps, had directed him back onto Division Street.

The passengers were evacuated from the bus and transported by ambulance to the local pub where The Shuttle Service Company bought them all a round of drinks. Although no injuries were reported and an alternate bus was quickly arranged to continue the trip, most of the passengers decided to forgo the casino and remain at the bar to further calm their nerves.

"I'm never leaving town again," insisted a visibly shaken Jerry Atrick. "Owen Big and I, we like to take the shuttle to a new casino every so often and try to squeeze a little more out of our social security checks, if you know what I mean. Well, no more. From now on when I get the urge to gamble, I'll just come here for the pull tabs. It's much safer than trying to navigate the roads these days."

The driver, Howie Blewit is relatively new to the job, according to a representative from The Shuttle Service Company. Co-workers described him as kind to animals and children, a bit overdependent on Google Maps for a bus driver, but completely harmless.

"It was your classic case of overthinking," Dr. Mel Practiss later told Flake reporters. "When faced with one or





more options, some people just can't make a decision. It happens all the time at restaurants."

"That's so like Howie" Blewit's wife said later in a phone interview with The Flake. "He's always had an inability to commit. We dated 15 years before we got engaged and it took another six to actually tie the knot. I'm not surprised at all."

Blewit was transported by ambulance to the local hospital to undergo further psychoanalysis, "just in case," officials said.



Members of the Goodview and Fairview chapters, however, weren't so lucky. Two were hospitalized and one reportedly lost an appendage.

Every year the Maple Lake Ice Fishing Derby attracts thousands of ice fishing enthusiasts from across the state and

N.I.P.I is always well represented.

"I just love ice fishing, I love everything about ice fishing, except actually catching fish. I think that's cruelty to aquatic life," Ima Nutt, member of the Freeborn N.I.P.I chapter said. "And I think it's just marvelous that Maple Lake is raising money for a fish house to stay warm in, of course they probably won't invite us Freeborns inside. They didn't exactly roll out the welcome mat to their lean-to last year, and those hand warmers they handed out, what a joke. They sure didn't help poor Seymour from Fairview. He's not so fair to look at anymore, if you get my drift," Nutt said.

Thursday night's raffle will take place at

7 p.m. at the Coat home, located at 1234 Bare Ave. The top prize is a one-year free N.I.P.I membership worth an estimated \$1,000. Also raffled off Thursday night, are several styles of birthday suits designed by renowned artist Mother Nature.


"And when you do go out," he said,
